ao **Acordo de Cooperação nº 002/2023**, celebrado entre a UNIÃO, por intermédio do SENADO FEDERAL, o **INSTITUTO NATURA** e a **ASSOCIAÇÃO GÊNERO E NÚMERO**, que tem por objeto a elaboração de uma plataforma de dados inédita sobre a Violência de Gênero, que consolide os dados públicos do sistema de justiça, segurança pública, saúde, assistência social e outros, incluindo a criação, pelo Senado Federal com o apoio das instituições cooperadas, de um índice de transparência de dados de Violência Contra a Mulher para estimular a organização, transparência e monitoramento de dados nos estados federativos.

A UNIÃO, por intermédio do **SENADO FEDERAL**, neste ato representado por sua Diretora-Geral, **ILANA TROMBKA**, o **INSTITUTO NATURA**, neste ato representado pelo Sr. **DAVID SAAD**, e a **ASSOCIAÇÃO GÊNERO E NÚMERO**, neste ato representada pelo Sra. **VITÓRIA RÉGIA GONZAGA DA SILVA**, tendo em vista a manifestação do Órgão Técnico, documento nº 00100.189847/2025-62-1, a concordância das COOPERADAS, documento nº 00100.189847/2025-62 (anexos II e III), o Parecer nº 807/2025-ADVOSF, documento nº 00100.205288/2025-45, a autorização da Senhora Diretora-Geral, documento nº 00100.240892/2025-18, e as demais informações contidas no Processo nº 00200.012675/2025-10, resolvem aditar o Acordo de Cooperação nº 002/2023, com base na sua Cláusula Sexta, no Ato da Diretoria-Geral nº 14/2022, na Política de Contratações do Senado Federal, instituída pelo Anexo V ao Ato da Comissão Diretora nº 14/2022, na Lei nº 13.019/2014 e mediante as seguintes Cláusulas:

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Natura Cosméticos S/A (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Getting paper copies
